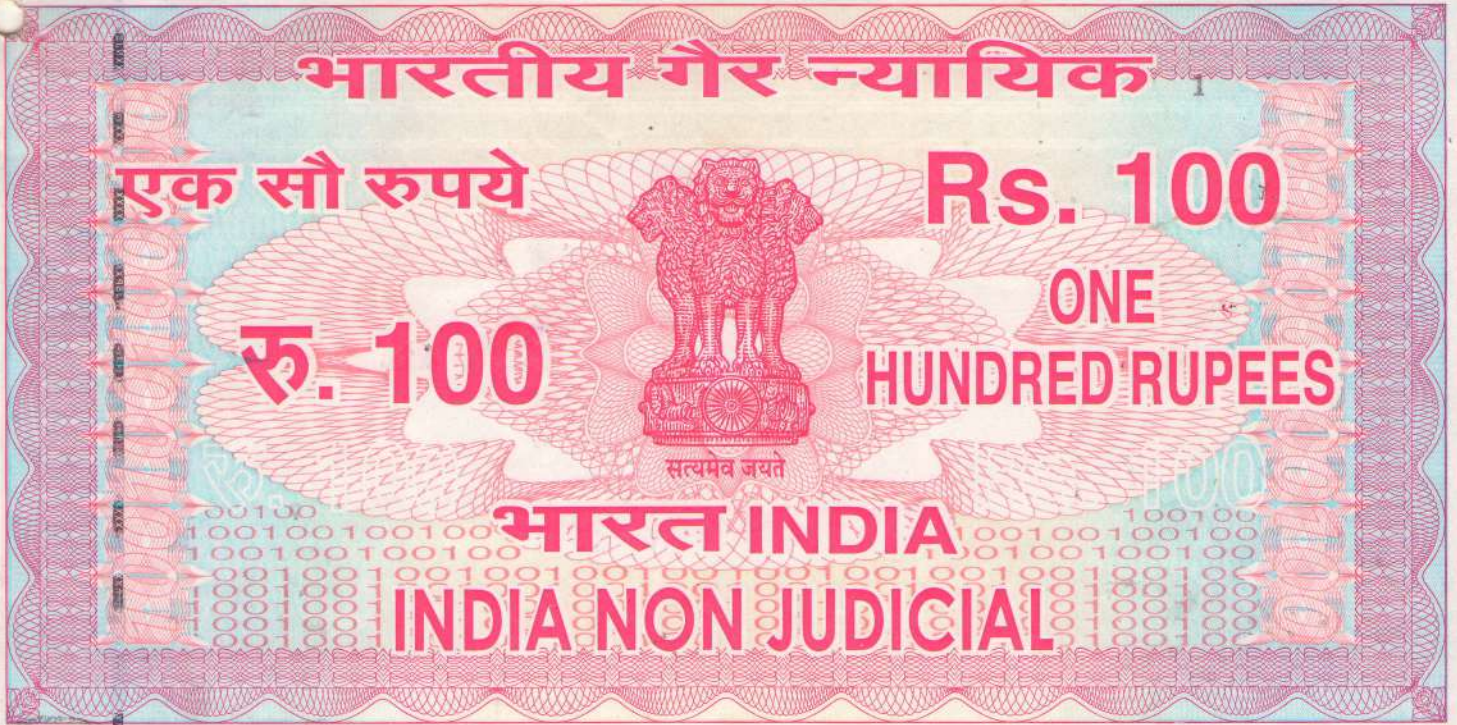

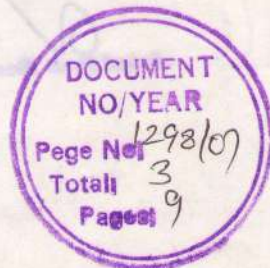

Whereas the TamilNadu Handicapped Federation Charitable Trust was founded by the deed of declaration of trust dated 26th April, 2007.

That I undersigned do hereby declare that I have irrevocably settled an amount of Rs.1,000/= (One Thousand only) for the sole purpose that it should form the nucleus and corpus fund of Rs.1,000/= and thus it has been accepted by the Trustees who have consented to act as Trustees subject to conditions hereinafter stated.

And whereas the trust has been engaged in various activities for the welfare of the handicapped in the state of TamilNadu since its inception.

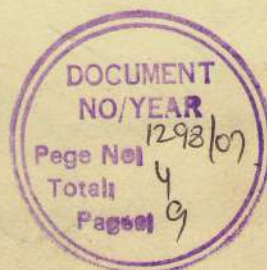
And whereas the Trust has been registered U/s 12 A of the Income tax act, 1961 and has been regularly filing its income tax returns and conducting its meetings regularly and electing its office bearers

And Whereas the Author Founder of the Trust is desirous of executing these presents, declaring the objects and purposes for which this Trust is constituted as well as other matters connected with administration on the Trust.

NOW THIS DEED OF DECLARATION OF TRUST WITNESSETH.

- 1) The name of the Trust shall be "Tamilnadu Handicapped Federation Charitable Trust"
- 2) The office of the Trust shall be located at No.13, Poomagal 2nd Street, Ambal Nagar, Chennai-97, and or such other place of places as the Trustees may decide. The objects with which this Trust is Founded are.
 - a) To promote the interest and welfare of the socially, educationally and economically downtrodden and disabled people.
 - b) To start and run educational institutions of technical and non-technical nature.
 - c) To conduct lectures, meeting, conferences, training programmes, seminars and surveys for the benefit and upliftment of persons with disability.
 - d) To provide a medium for the exchange of information about the activities, objectives and experiences of similar organizations and to co-ordinate with other welfare organizations and execute common programmes useful for the upliftment of persons with disabilities.
 - e) To help the socially, educationally and economically weaker sections of differently-abled to acquire need based requisite, minimum knowledge and skill in the field of economic activities

- f) To assist, maintain and promote among the differently abled person, programmes with regard to Cottage Industries, Co-operatives, Animal Husbandry, Women and child Welfare Programmes and other avenues for economic rehabilitation.
 - g) To affiliate to National Organisations, including their specialised agencies and to co-operate with them in all matters concerning the education or welfare of the differently-abled persons at large in India.
 - h) To assist, maintain and promote among the differently abled person, programmes with regard to Cottage Industries, Co-operatives, Animal Husbandry, Women and child Welfare Programmes and other avenues for economic rehabilitation.
 - i) To affiliate to National Organisations, including their specialised agencies and to co-operate with them in all matters concerning the education or welfare of the differently-abled persons at large in India.
 - j) To establish and maintain institutions, reading rooms, study classes, hostels, evening classes, sports infrastructures, crèches and recreation centres.
 - k) To publish a papers, journals, pamphlets, books etc. for promoting the objects of the Trust.
 - l) To provide health education, training of hygiene and medical assistance and treatment for the differently-abled persons.
 - m) To provide education in the field of economic development and to help the poor differently abled persons to start their own co-operatives or self help groups to sell their own products for their own benefit.
 - n) To support the needy and poor differently-abled persons to get their benefits through Government schemes and Bank Loans and if it is necessary to stand Guarantee for these persons.
 - o) To initiate arrangements for starting homes/hostels for the benefit of all categories differently abled persons.
 - p) To initiate increase in employment opportunities for Handicapped persons in Private and Public Sector.
 - q) To lobby for the rights of differently-abled with Central Government, State Government, Union Territories, Local Bodies, Quasi Government and Non-Government Organisations (NGOs) etc.
 - r) To liaison with organizations with similar objectives and with individuals, group of persons, bodies of people, societies, Trusts and other organizations for the benefit and welfare of the differently-abled persons.
 - s) To raise funds by conducting Charity programmes, getting grants from Central and State Governments, Industries, NGOs and other organizations.
 - t) To accept contributions in cash or kind from any person or persons, society or company for the furtherance of the objects of the Trust
 - u) To do all acts that may be incidental to and/ or necessary for the realization of the above objects of the Trust.

- v) The above objects shall be independent of each other and the Board Of Trustees may from time to time apply the funds of the Trust in carrying out all or any of the objects of the Trust as they deem fit.
- w) All the activity of the Trust shall be done in furtherance of and for the attainment of its objects and no activity shall be carried out with the intention of earning a profit.

Notwithstanding the above, the Trust may conceive of and implement any other project designed to advance and for the furtherance of the objects of the Trust.

- 3) The benefits of this Trust shall be open to all, irrespective of Cast, Creed, Religion, sex etc.,
- 4) The activity of the Trust shall be carried on in India only and no activities shall be carried on outside India.
- 5) The Trust shall not carry on any activity with the intention of earning a profit.
- 6) The funds of the Trust shall be invested in accordance with the provisions of Sec. 13 (1)(d) r.w. Sec. 11(5) of the Income Tax Act, 1961 as amended from time to time.
- 7) The Income and funds of the Trust shall be utilized solely towards the objects of the Trust and no portion of such sums shall be utilized for payment to the Trustees by way of profit, interest, dividend etc.

8) BOARD OF TRUSTEES

a) The management, administration and control of affairs of the Trust shall vest in a Board of Trustees which shall consist of the following members having the corresponding designations:

- i) Shri G. Chidambaranathan Founder Trustee/ President
- ii) Shri P. Simmachandran [REDACTED] /Trustee/Secretary
- iii) Shri B. Chandrakumar Trustee/Treasurer
- iv) Shri S Elango Trustee
- v) Shrimathi Padma Gopal Trustee
- vi) Shri K. Srinivasan Trustee
- vii) Shri Shankara Mahadevan Trustee
- viii) Shrimathi Seethalakshmi Mahadevan Trustee
- ix) Shri T. Karuppaiah Trustee
- x) Shri R. Muralidharan Trustee

b) The Trustees shall I have the power to appoint more members in addition to or to fill up any vacancy in the Board of Trustees and to prescribe the qualifications and terms of office of such members and also manner in which they are to be taken into the Board, and other matters incidental thereto.

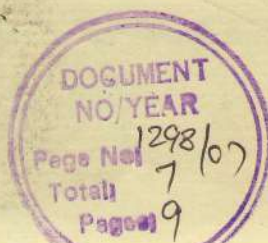
- c) The number of Trustees shall be neither less than five nor more than fifteen.
- d) If the number of Trustees of the Trust falls below the minimum prescribed in Sub-clause (c) supra, the Board can meet for the purpose of filling the vacancy, and the Board shall be competent to transact business only when the minimum is brought to the number fixed in Sub-clause (c) supra.
- 9) The Board shall have the power to accept contributions in money or property either by way of addition to the Trust funds generally or for one or more of the specified objects of the Trust, and in either case such contributions shall be dealt with either as corpus or income according to the directions of the Donors at the time of the gift.

10) MANAGEMENT

With a view to augment the Trust Fund, and for proper administration of the Board Trustees shall have the following powers:

- a) To obtain and accept aids, grants and other help from Government and institutions, Public or Private.
- b) To accept any bequest, gift, or donation and to invest the same and apply the income arising there from or to resort to the Capital thereof, for the furtherance of any of the objects of the Trust.
- c) To invest and deal with the Trust fund in such a manner as the Trustees as required or authorized to invest such moneys by the law for the time being enforced.
- d) To purchase, hire, take on lease or otherwise acquire any movable or immovable property for the furtherance of the objects of the Trust.
- e) To sell, lease, exchange or otherwise dispose of any property or interest in property movable or immovable, belonging to the Trust.
- f) To open and operate Bank account or accounts at such Bank or Banks as the Trustees may decide from time to time, such Bank account/s shall be operated on the Joint signatures of any of any Two of the following:
The President, The Secretary or the Treasurer
- g) To borrow or raise money and for that purpose to pledge, mortgage or otherwise create a charge on the properties movable or immovable for the benefit of the Trust.
- h) Generally, to do all such other things as are incidental to or conducive to the attainment of the above objects.

The powers conferred above shall be exercised in such a manner that the income or the property of the Trust inures for the benefit of the Public. The income or the property of the Trust or any part of such income or property shall not be used or applied directly or indirectly for the benefit of any person referred to in Subsection (3) of Section 13 of the Income Tax, 1961 or as indicated in Subsection (2) of the said Section.

11) The Trust shall not acquire/ alienate any immovable property except with the prior approval of the commissioner of Income Tax/ Director of Income Tax (Exemptions), Chennai.

12) Meetings of the Board of Trustees and minutes.

The meetings of the Board of Trustees shall be held as often as necessary. The minutes of the proceedings of every meeting of the Board of Trustees, shall be entered in a book to be kept for that purpose and signed by the President and shall when so entered and signed, be conclusive evidence of the business transacted at such meeting.

13) POWERS AND DUTIES OF THE BOARD OF TRUSTEES

Without restricting the general powers and duties the following powers and duties are given to and conferred upon the Board of Trustees viz.

POWERS

- a) To raise funds in the name of the Trust.
- b) To invest funds.
- c) To compound or abandon or delay to enforce any debt or demand of the Trust to institute, defend or compromise any proceeding or to correspond and represent the Trust before the appropriate authorities as and when required.
- d) To frame regulations or to lay down procedures in regard to the functions of the Trust, and to modify, alter, add to or rescind such regulations or procedures.
- e) To receive and disburse money.

DUTIES

- a) To specify which of the officers shall keep books of account, keep other books and registers, shall prepare returns and statements and keep cash.
 - b) To maintain timely and regularly true accounts of the Assets and Liabilities in proper books and form.
 - c) To maintain the list of beneficiaries and other books and accounts up to date.
 - d) To have the books, accounts and relevant records audited regularly and for that purpose to appoint Auditors and to fix and pay their remuneration.
 - e) To perform other duties in furtherance of the objects of the Trust.
- 14) All or any of the powers vest in or exercisable by the Trustees shall be capable of being performed or exercised by a majority of the Trustees, and the action or decision of such majority shall be valid and effectual as if done or made by all the Trustees unanimously

15) ADVISORY COMMITTEE

The Board of Trustees may appoint an Advisory committee/s for advising the Trustees in the administration of any institution or activity under the Trust. The constitution of the Advisory committee/s, their term of office, powers and such other matters shall be decided by the Board of Trustees.

16) OFFICIAL YEAR

The official year of the Trust shall be the year ending on 31st of May every year.

17) ANNUAL ACCOUNTS

The Trust shall maintain regular accounts of its receipts and expenditure. After the close of the official year and as early as possible, the books of accounts of the Trust shall be closed and a statement of Income and Expenditure together with a Statement showing Assets and Liabilities of the Trust shall be prepared, audited by a qualified Auditor and placed before the Board of Trustees for its review and approval.

GENERAL

- 18) No part of the Trust fund, other Assets or the Income of the Trust shall be applied at any time for any purpose other than those declared in the Trust Deed.
- 19) The Board of Trustees, by their unanimous decision, may add to delete or modify the provisions of the Trust Deed or make and prescribe rules and bylaws regulating its carrying out the objects of the Trust, so as to further the objects of the Trust only after getting the previous approval of the Commissioner of Income Tax/Director of Income Tax (Exemptions)
- 20) In the event of the extinction of the Trust, the properties and other Assets of the Trust shall be handed over to a Charitable Trust or Institution having objects similar to those declared in this Deed.
- 21) It is hereby declared that the Trust hereby created shall be irrevocable.
- 22) In respect of matters not provided for herein, the provisions of the Indian Trust Act, 1982 shall apply.
- 23) At present the Trust does not own any immovable property.
